At its multiple clinics throughout Santa Barbara County, SBNC is a critical health safety net for the community and provides care to over 22,000 patients a year - nearly 30% of which are children.

The Supporting the Safety Net award recognizes a community-based organization or individual that exceeds expectations for care by implementing programs to meet the health needs of underserved populations. SBNC provides primary care to 26% of CenCal Health's membership within SBNC's service areas.

CenCal Health offers weekly EFT payments! For organizations/providers not enrolled to receive EFT payments, effective July 5, 2019, your organization will return back to our biweekly payment cycle, which will be paid on the first and third Friday of every month.

We highly recommend enrolling into the electronic funds transfer process. Enrollment is easy and once enrolled, payments will be made weekly! If you are the CenCal Health provider portal administrator for your organizations, you can enroll via the portal.

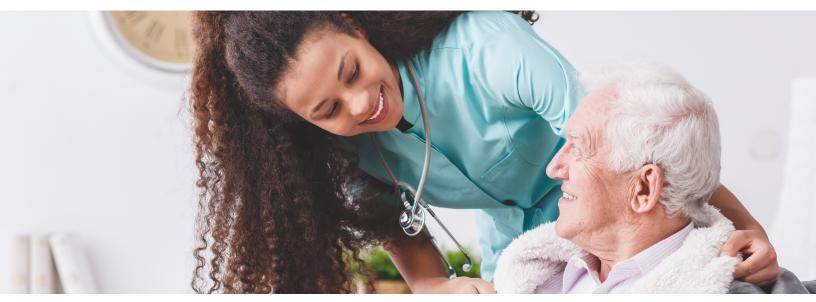

Updated Preventive Health Guidelines

CenCal Health must cover and ensure all preventive and medically necessary diagnostic and treatment services for adult and pediatric members as recommended by:

- U.S. Preventive Services Task Force (USPSTF)
- American Academy of Pediatrics (AAP)
- Centers for Disease Control (CDC)
- Child Health and Disability Prevention Program (CHDP)

The recommendations from these professional organizations are summarized in CenCal Health's 'Preventive Health Guidelines' member handout, which is included annually in the member newsletter and distributed to all new health plan members. DHCS Announces New Medi-Cal Managed Care Quality Performance Metrics

The California Department of Healthcare Services (DHCS) recently announced new statewide requirements to measure and improve clinical quality of care. All California Medi-Cal Managed Care plans will be required to annually report on a subset of the Centers for Medicare & Medicaid Services quality measures for children and adults, reflecting care provided during calendar year 2019. This change expands upon HEDIS® measures previously reported by CenCal Health. New measures that DHCS and CenCal Health will evaluate include:

- Well-Child Visits in the First 15 Months of Life
- Developmental Screening in the First 3 Years of Life
- BMI Assessment for Children, Adolescents and Adults
- Adolescent Well-Care Visits
- Screening for Depression and Follow-Up Plan, age 12 and older
- Antidepressant Medication Management

- Follow-Up Care for Children Prescribed Attention-Deficit/ Hyperactivity Disorder Medications
- Concurrent Use of Opioids and Benzodiazepines
- Use of Opioids at High Dosage in Persons Without Cancer
- HIV Viral Load Suppression
- Chlamydia Screening in Women, age 16-24
- Contraceptive Care for Women

CenCal Health's goal is to meet or exceed the Medicaid 90th percentile, with performance among the nation's best 10% of Medicaid health plans. For most aspects of care, DHCS will hold plans accountable to at least achieve the Medicaid 50th percentile. Opioid and Benzodiazepine Concomitant Use Safety Edit

With the approval of CenCal Health's Pharmacy and Therapeutics Committee and in coordination with its Pharmacy Benefits manager (MedImpact), CenCal Health continues to implement a multiphase plan to deter overutilization of opioids, and update utilization management measures.

Effective 9/1/19, CenCal Health will implement an opioid and benzodiazepine concomitant use safety edit. The safety edit is a point of sale (POS) intervention that will identify and deny concurrent use of opioids and benzodiazepines when there is any overlap in the day supply. Interventions will work bi-directionally and stop claims when there is an opioid-benzodiazepine claim overlap or vice versa.

In order to override these rejections, the pharmacist may conduct a Drug Utilization Review (DUR) and submit the applicable override that outlines the specific actions taken by the pharmacist. The dispensing pharmacist can bypass the soft edit by using the following overrides:

4C (Hospice)	1A (Filled As Is, False Positive)	
4B (Palliative Care)	1B (Filled As Is, Not Relevant)	
4D (Cancer)	4A (Prescribed with Acknowledgements)	
1G (Prescriber Approval)	3G (Drug Therapy Unchanged)
